We are extremely grateful for the bipartisan support the bill received and the swift action by both the Legislature and the Governor to get these changes made before the Ascend West Virginia program launch.

We have a real opportunity here, as 37 percent of the nation's workforce are now about to work remotely...permanently. We are making it our mission to get them to the Mountain State. I firmly believe that this program can – and will – grow enormously over the next several years as West Virginia becomes the nation's premier destination for remote workers. $\ lackbreak V$
