West Virginia Infrastructure Construction Forecast

The West Virginia Infrastructure and Jobs Development Council was created by the West Virginia Legislature in 1994 to serve as a funding clearinghouse for water and wastewater projects around the state. Governor Jim Justice serves as council chairman, with Deputy Chief of Staff Ann Urling serving as his designee. The council meets monthly. For more information, visit www.wvinfrastructure.com.

The 12-month construction forecast shows the projects that the Council has made recent binding commitments to or has pending binding commitments with, which should close/ proceed to construction in the next 12 months. As you can see, the Council has commitments, or pending commitments, for 58 projects with over \$66 million from the Infrastructure Fund program leveraging funding from other federal, state, and local funding programs totaling over \$325 million of water and wastewater infrastructure projects.
